# To the Item No. 3 of the Notice:

Mr. Shaileshbhai Parshottambhai Bavishiya (DIN: 01908191) is appointed as Managing Director of the Company under section 196, 197, 198 and 203 of the Companies Act, 2013 and Rules made thereunder for a term of five consecutive years from August 29<sup>th</sup>, 2022 to August 28<sup>th</sup>, 2026 in the Board Meeting of the Company held on August 29<sup>th</sup>, 2022.
